HB 327 Provides that a locality may require by ordinance that certain structures within a historic district not be demolished except in compliance with the local ordinance, unless the local building department

The Commission, among other things, must (i) identify the vestiges and assess the effects of the transatlantic slave trade on African Americans, the Commonwealth, and modern societal problems and public policies, (ii) explore and showcase the contributions of African Americans in building Virginia and the nation, (iii) determine the educational and economic value to the Commonwealth of preserving sites and facilities of historic and archaeological significance to African American culture and contributions, and (iv) recommend feasible and appropriate options to resolve lingering societal problems whose roots lie in slavery. #### **Please Support Crime Prevention**

As you are aware the City of Lynchburg will be presenting 4 public forum meetings to obtain input from citizens regarding the current budget situation. Please come out to these meeting and listen to the presentations. We are asking for your support and your willingness to voice your concerns to City Council. In these difficult times good programs such as Crime Prevention including the Neighborhood Watch Program are in danger of being cut yet again. The following information shows current issues effecting the Police Department as related to the ongoing budget crisis.

#### Turnover/Operational Vacancies-

Excessive turnover in recent years has left us extremely inexperienced and with significant operational vacancies. The LPD has lost 42 officers since January 2010 (25 to voluntary resignation). This is not isolated to the last two years either, we have lost 82 officers since January 2007, which is essentially half of our sworn staff. This is a huge concern as we move forward. With this inexperience comes "growing pains". Simply put, you "police" differently with experience. In addition, experience is not something you gain overnight. It will take time to reverse what has been taking place for a number of years now, and it is imperative that this issue be addressed now.

The following provides some insight regarding our current experience levels:

69 officers with less than 5 years of experience 51 officers with less than 3 years of experience

\*\*Generally takes about 5 years for an officer to gain the experience necessary to be fully competent in a wide range of areas)

The numbers related above are very concerning and have been created by persistent high turnover. In addition, we have 10 senior members of our staff who are eligible to retire in the next 12 months (2 have already retired since this information was compiled). It is concerning that we may lose 10 senior members of our staff when we don't have much experience to begin with. This just compounds our issues in this area. It is vital to any police department to have an experienced staff. Experience ensures appropriate action and the ability to train and guide new officers as they learn their craft. The lack of experience limits those that are eligible for promotion. Promotion of leaders determines the effectiveness and professionalism of the Department.

#### Positions that have been vacated due to staffing issues:

Community Relations Officer School Resource Officer at Dunbar Middle School School Resource Officer at Sandusky Middle School School Resource Officer at Linkhorne Middle School DARE Officer

\*\*\*These officers were transferred back into patrol in June 2011 as we attempted to address 19 operational vacancies (15 in patrol) and provide more experience in the patrol function. Patrol is the core service we provide to the community.

#### Specialized Units that have been eliminated due to staffing issues:

Street Crimes Team - This is a uniformed interdiction team that aggressively targets Street-level drug activity. This team is very effective at suppressing street-level violence.

\*\*\*This unit cannot be staffed at an adequate level as we deal with staffing issues within the patrol function.

#### Costs Involved in Excessive Turnover/Operational Vacancies

Our excessive turnover is costly. It is very costly to a community to train new officers only to lose them within a short period of time. We estimate that we invest approximately \$110,000 in salary and benefits, training, and equipment in a 2-year officer. When a young officer leaves, we start over again.

Our overtime totals for the last 4 fiscal years are as follows:

FY'08 - \$600,902

FY'09 - \$524,159 FY'10 - \$387,928 FY'11 - \$484,892

FY'12 – projected to be in excess of \$500,000

\*\*\* There is a direct correlation between overtime costs and operational vacancies. Overtime costs increase when we experience significant staffing shortages.
