Guest Speaker:

R. Chamblis Light, who will enlighten us on, **“Restoring a Family Cemetery – Where to Begin.”**

Cham’s ancestors of the Clark, Leftwich and Moorman families are amongst the earliest settlers in Central Virginia. Cham will give you a brief overview of his experience in restoring one of his family cemeteries; from reviewing the Virginia Codes, finding records in the Clerk’s Office, acquiring professional services from archeologists, maintaining smooth relations with the land owners and other family members and finding the funding for such a project.

Cham has been an attorney at Nationwide Insurance since 1985. He was one of the founding board members of the Free Clinic of Central Virginia. He has also served on the Executive Committee of the Library of Virginia, as President of both the Lynchburg Historical Foundation and the Southern Memorial Association/Old City Cemetery and is currently on the board of the Jones Memorial Library. Cham is married to Edie Light and has two grown children, Trey and Paige.

## Lynchburg Museum To Sell Reproduction Gargoyles From Old Court House

When the City of Lynchburg, Virginia built a new court house in 1855, the design called for wooden "Corinthian lions" to be carved and placed on the exterior of the Greek Revival building as gargoyles. Based on the surviving original gargoyle in the Lynchburg Museum collection, the woodcarver must have thought lions looked somewhat like pigs.

When the Museum moved into the court house in 1977, the original gargoyles had rotted, and wooden replacements were carved by local artisan Michael Creed. Creed related that he cut sections from a yellow pine beam from an old tobacco warehouse and hand-carved the replacement gargoyles to match the originals.

Now 34 years later, the 1970's versions are being replaced. The Lynchburg Museum will retain one to document this aspect of the building's history, donate one to the Lynchburg Historical Foundation, and five others will be sold on eBay with proceeds to benefit the Museum.

Each gargoyle weighs 29 pounds, measures 15 inches long, 13 inches wide, and 12 inches tall and has a 12-inch metal rod on the rear which was used to mount it to the building. Museum Director Douglas Harvey said, "We talked with our Board and City officials, and everyone thought it a good idea to share these with the public, generate funds to support the Museum, and not take up our limited storage with non-original items. The gargoyles are really collectible folk art at this point so we hope to see some real bidder interest."

Anyone wishing to place a bid or to just view the images, the five gargoyles will be featured on eBay (listed under Antiques, Collectibles, Folk Art, and Architectural Elements) beginning Wednesday, December 7. During a 10-day bidding period, they will be sold separately and will vary somewhat in condition with cracks, small areas of soft wood, or flaking paint.

**Annual Absentee Ballot  
Program**

The Commonwealth of Virginia offers an  
absentee ballot application program for  
chronically ill or disabled voters whereby  
a voter may apply to receive absentee  
ballots for each election without having  
to submit a separate application for each  
election during the year.

For example, in 2012, a voter would only  
have to submit one absentee ballot appli-  
cation instead of four. The first time a  
voter submits this annual application, he/  
she will need to have a doctor's signature  
certifying that the voter is unlikely to be  
able to go to the polls during the year.  
After the first-time application, a renewal  
application will be sent to the voter in  
December for the upcoming calendar  
year.

The City of Lynchburg's Registrar's Of-  
fice is currently mailing applications to  
those voters already in the program.  
Residents who would like more informa-  
tion about the program can call the Reg-  
istrar's Office at 847-1609.

### American Brewery

As seen from the back seat of George Holback's family station wagon more than 50 years ago, the American Brewery building in East Baltimore was "a place the Addams family might have lived."

### Acworth Meetinghouse

For nearly two centuries, a beloved icon known locally as the Church on the Hill towered above the rooftops of Acworth, N.H. When residents noticed in 2005 that the steeple atop Acworth Meetinghouse was leaning, they sprang into action to save the 1821 building.

### Downtown Women's Center

The residents of the Downtown Women's Center in Los Angeles have found a fresh start in their new home on San Pedro Street. And the same can be said of the center's 1926 Gothic Revival structure, which reopened last December after a \$26 million restoration.

### Seashore Farmers' Lodge
