Through this project, we will be able to see them once again, and be able to encourage others to invest in our neighborhood.

Preservation Virginia Legislative Alert

[HB 1137](#) The bill, as currently written, could undermine the integrity of new local historic districts and its amendment provision could have an impact on existing districts. Local historic districts are an important tool and used by local governments to ensure quality changes and development. If enacted, it could have the affect of creating "Swiss cheese" in these districts and would be difficult to administer. Rural and urban local historic districts alike would be affected. There has been no outreach to the conservation or preservation communities, nor to our knowledge, local governments or local ARBs.

Contact Delegate Danny Marshall and your delegate to express concern about the bill. Ask if consideration of this bill can be delayed until the 2013 session so that preservationists, conservationists and ARB members can help describe the impacts and offer workable suggestions. Other Bills of Interest

[HB 327](#) Provides that a locality may require by ordinance that certain structures within a historic district not be demolished except in compliance with the local ordinance, unless the local building department determines that it constitutes such a hazard that it shall be razed and removed. [HB 580](#) and [SB 473](#) Both bills remove the requirement for the consent of both the Governor and the General Assembly in cases where real property interests in the Area of Operation at Fort Monroe are sold. <http://leg1.state.va.us/cgi-bin/legp504.exe?121+sum+HB580> and <http://leg1.state.va.us/cgi-bin/legp504.exe?121+sum+SB473>

Summary of Legislation to Date

Below, please find an updated table reflecting legislative items that may be of interest to Preservation Virginia.

[HB 246](#) Prohibits any committee of the General Assembly from reporting a new tax credit or renewing a tax credit without a sunset date within five years. Patron Delegate Cline <http://leg1.state.va.us/cgi-bin/legp504.exe?121+sum+HB246>

New: No new action. Bill remains in subcommittee. Likely to be called for hearing next week.

Ervin David Porter

David was born in Kentucky, October 20, 1924, and at an early age given to teenage parents who then gave him up for adoption in New York where he was adopted by his parents in Concord, New Hampshire. His parents also adopted his younger sister who was born in England and is currently living in a cabin she built in Vermont. His father died in the New Hampshire flood in 1936 when David was 12 yrs old, his mother, then, raised him and his younger sister. David once told me how he used to collect sap with a bucket from the maple trees for syrup. In the 40's David served in the Navy. In the 50's David met Charles Bedat and they bought a house in Stratford, Connecticut. David was a friend and loving partner of Charley's for 58 years. They later moved to Diamond Hill in Lynchburg, Virginia. David wanted his body donated to "The Anatomical Society of Virginia" which provides cadavers for research at universities in Virginia. David was a "Bridge Life Master" and he operated his own club in Bridgeport, CT. He was instrumental in advancing the Lynchburg Bridge Club that now has a permanent home on Wiggington Rd. Charley said he was as happy as a pig in poop when he was playing Bridge. David loved to smoke his pipe and I loved the smell of it. I often knew when he was out walking, by catching a wiff of his aromatic pipe tobacco. David helped me a lot; he helped me at times when I needed it most, loading furniture for my business. Whenever I called he would come over to help me load furniture for delivery. He even went with me once for a delivery in Charlottesville. I'll never forget he once said "It's not the inability, it's the ability that counts in a person", and, that phrase stuck with me. David wanted to be helpful, useful, and make a difference. He certainly did that with me. David was a good man and I miss him, but, he's in a better place today.

DHHS Board of Directors has proposed a change to paragraph 4, Article VIII: Meetings of Diamond Hill Historical Society Articles of Incorporation to be voted on in the April membership meeting:

Paragraph 4, Article VIII: Meetings currently reads: Thirty percent of the voting membership of the Society shall constitute a quorum, with the following exceptions: Fifty percent of the voting membership shall constitute a quorum for the Annual Meeting.

David Porter of Lynchburg passed away on February 15, 2012, at Lynchburg General Hospital. There was no viewing or service. The EMS ambulance picked up Dave after he collapsed on the morning of the 15th. He died at Lynchburg General later that day.

David and Charles moved to Lynchburg from Connecticut and purchased the Dingee-Stalling House. The previous owner had allowed the house to become very run-down; so they hired Mike Murphy to renovate the house. Mike and his wife Carol were living in the Jones House, 601 Pearl Street, at that time. The Dingee-Stalling House was one of several houses in our historic district that Mike renovated.

During the many years they've lived on Diamond Hill, Charlie and Dave have been active DHHS members and continuously supported our organization and our neighborhood.
