## Federal and State Rehabilitation Tax Credits

The preservation of historic buildings benefits communities. Historic places connect us to our heritage and enrich the quality of our lives in many tangible and intangible ways. Their preservation also provides demonstrable economic benefits.

Through the federal and state rehabilitation tax credit programs, property owners are given substantial incentives for private investment in preservation, resulting in enormous advantages to the public. Both the federal and state tax credit programs are administered in Virginia through the Department of Historic Resources.

State tax credits are available for owner-occupied, as well as in-

come-producing buildings. If your property is income-producing, you may also be able to take advantage of federal tax credits. Also, information and assistance with tax-credit projects may be requested from DHR's Richmond office. Contact Elizabeth Tune at (804) 482-6093 or Julie Langan at (804) 482-6087.

A study conducted in 2007 (and updated in 2010) concluded that since the state tax credit program's inception in 1997, it has spurred private investment of approximately \$1.5 billion in the rehabilitation of more than 1,200 landmark buildings. This investment in turn has generated an economic impact of nearly \$1.6 billion in the Commonwealth and created more than 10,700 jobs and \$444 million in associated wages and salaries (for more information, see this January 2008 publication, "Prosperity through Preservation.").

This money represents costs paid into the construction industry for architects, contractors, craftsmen, and suppliers, with a corresponding increase in local employment. The capital improvement to the buildings results in significant increases in local property taxes, as well as a general enhancement in commercial activity. The rehabilitated buildings provide needed housing (in many cases, low- and moderate-income housing), and office, retail, and other commercial space. As a result, communities benefit from property improvements, blight removal, and increased occupancy of buildings in historic core neighborhoods.

#### MEMBERSHIP CLASSIFICATIONS

**EXISTING ACTIVE MEMBERS:** those who are the owners of D.H. property, plus adult members of their family who live in the residence, and whose dues are paid for 2013. Dues are \$10 per person.

**PROSPECTIVE NEW ACTIVE MEMBERS:** those who are new owners of D.H.property (plus adult members who reside in the residence), but not members of D.H.H.S., who wish to join for 2014. There is a one-time initiation fee of \$5 for each person, plus dues of \$10 for each.

**PROSPECTIVE RE-ACTIVATED ACTIVE MEMBERS:** those who were previously Active Members but whose dues lapsed. Dues for 2014 are \$10.

**EXISTING ASSOCIATE MEMBERS:** those who do not own property in D.H., but whose 2013 dues as Associate Members are current. Their dues for 2014 are \$10.

**PROSPECTIVE NEW ASSOCIATE MEMBERS:** those who do not own D.H. property and are not Associate Members, but wish to become Associates. Dues are \$10.

## **Neighbor Notes: Geoffrey Kershner and Endstation Theatre Company**

Resident Geoffrey Kershner recently received news that his staging and adaptation of Shakespeare's *Taming of the Shrew* was selected to be the headline performance at the Virginia Theatre Association's annual conference (October 25-27, 2013). The show was part of the Endstation Theatre Company's summer series, and was performed downtown as they took the show on the road this past summer. At the festival it was performed in front of approximately 1,000 participants.

For the past two years, Endstation has been voted "Best Live Theatre" in the Lynchburg News and Advance, and was the recipient of the 2013 Virginias for the Arts "Rising Star" award. Their work was also featured in this year's "Random Acts of Culture," a project planned and put on by the Economic Development Council. This event included free lunch time performances at many nearby businesses and venues.

Geoff grew up in Amherst, VA. His dad was a professor of theatre at Sweet Briar College and still holds that position today. He received his BA in Acting from University of the Arts in Philadelphia. After college, he was selected as an apprentice for The Arden Theatre Company's Professional Apprenticeship Program. He received his MFA in directing from Florida State University's School of Theatre.

In 2006, Geoff brought fellow FSU graduate Krista Franco to his childhood home in the beautiful Blue Ridge Mountains of Central Virginia. Both agreed that Central Virginia, would be an ideal home for a theatre company, and saw an opportunity to bring quality, live theatre to the area. So they created Endstation Theatre Company, a non-profit organization focused on creating theatrical experiences for and about Virginia. Since then, Endstation has become a summer company, producing reinvented outdoor classics on the bucolic Sweet Briar Campus every year. Audiences can enjoy a picnic and a glass of wine, cider or beer while watching an incredible story unfold before them. Endstation has also produced plays and musicals that speak to the region. Endstation actors, interns, and staff members come from all over the country to produce this work in Central Virginia, making Endstation the area's only professional theatre company.

After running the company from afar nine months out of the year, Geoff was offered a faculty position at Lynchburg College, allowing he and his wife Ashley to live in Lynchburg year-round, and they



chose Diamond Hill for it's lovely homes and convenient location. Geoff has taught acting and directing at a number of colleges and universities including Randolph College, Sweet Briar College, Florida State University, and Daytona State College. He is currently the Artistic Director for Endstation Theatre Company (www.endstationtheatre. org) and an Assistant Professor of Theatre at Lynchburg College.
